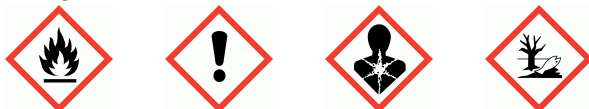

#### SECTION 4: First aid measures

## Corroless Thinners No. 2

### 4.1. Description of first aid measures

<b>General information</b>	If in doubt, get medical attention promptly. Never give anything by mouth to an unconscious person.
<b>Inhalation</b>	Move affected person to fresh air at once. If breathing stops, provide artificial respiration.
<b>Ingestion</b>	Get medical attention immediately. Keep affected person warm and at rest. Do not induce vomiting.
<b>Skin contact</b>	Remove contaminated clothing immediately and wash skin with soap and water. Do not use organic solvents.
<b>Eye contact</b>	Rinse immediately with plenty of water. Continue to rinse for at least 10 minutes.
<b>Protection of first aiders</b>	First aid personnel should wear appropriate protective equipment during any rescue. It may be dangerous for first aid personnel to carry out mouth-to-mouth resuscitation. Wash contaminated clothing thoroughly with water before removing it from the affected person, or wear gloves.

### 4.2. Most important symptoms and effects, both acute and delayed

<b>Inhalation</b>	May cause respiratory irritation. Prolonged or repeated exposure may cause the following adverse effects: Coughing. May cause nausea, headache, dizziness and intoxication.
<b>Ingestion</b>	Pneumonia may be the result if vomited material containing solvents reaches the lungs. May be fatal if swallowed and enters airways. Ingestion may cause severe irritation of the mouth, the oesophagus and the gastrointestinal tract. May cause stomach pain or vomiting.

### 5.2. Special hazards arising from the substance or mixture

<b>Specific hazards</b>	The product is flammable. Fire-water run-off in sewers may create fire or explosion hazard. Vapours are heavier than air and may spread near ground and travel a considerable distance to a source of ignition and flash back. Control run-off water by containing and keeping it out of sewers and watercourses.

**Special protective equipment for firefighters** Wear positive-pressure self-contained breathing apparatus (SCBA) and appropriate protective clothing. Firefighter's clothing conforming to European standard EN469 (including helmets, protective boots and gloves) will provide a basic level of protection for chemical incidents.

### SECTION 6: Accidental release measures

#### 6.1. Personal precautions, protective equipment and emergency procedures

**For non-emergency personnel** No action shall be taken without appropriate training or involving any personal risk. Evacuate area. Keep unnecessary and unprotected personnel away from the spillage. Do not touch or walk into spilled material. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Do not breathe gas, fume, vapours or spray. Provide adequate ventilation. If ventilation is inadequate, suitable respiratory protection must be worn. Place waste in labelled, sealed containers. Large Spillages: Eliminate all ignition sources if safe to do so. Stop leak if safe to do so. Move containers from spillage area. No smoking, sparks, flames or other sources of ignition near spillage. Avoid the spillage or runoff entering drains, sewers or watercourses. Dispose of waste via a licensed waste disposal contractor. The contaminated absorbent may pose the same hazard as the spilled material.

#### 7.1. Precautions for safe handling

#### Appropriate engineering controls

As this product contains ingredients with exposure limits, process enclosures, local exhaust ventilation or other engineering controls should be used to keep worker exposure below any statutory or recommended limits, if use generates dust, fumes, gas, vapour or mist.
